Intermediary models are possible, depending on the number of chief actors and the degree of equality or inequality of forces among the chief actors". Over time, new security challenges such as piracy, armed robbery, terrorist acts, illicit arms trafficking, the proliferation of weapons of mass destruction, drug and human trafficking, migrant smuggling, and illegal, unreported, and unregulated fishing have surfaced. These threats, combined with the challenges posed by climate change, are commonly referred to as non-traditional threats. All littoral nations of the ocean confront these challenges. Consequently, nations are compelled to choose cooperation as a means to address these security threats. Thus, Maritime Security also encompasses initiatives aimed at mitigating risks and vulnerabilities through collaboration and coordination. The traditional aspects of Maritime Security remain pertinent in the Indian Ocean Region (IOR). India and China are currently engaged in strategic competition to safeguard their respective maritime and national interests in this area.
